Post Mortem Event – Tuesday 11th October 2016 at Dulverton Farmers Hunt Kennels, East Anstey

Due to the overwhelming response to our last event held in May. We are delighted to work with AHDB and Animal and Plant Health Agency (APHA) to bring together another session on the role of post mortems and the benefit they have to farm business, what can we learn from them and how can they be used as part of the health plan, followed by a practical session.

Headwaters of the Exe – Visit to Pynes Water Treatment Works – Wednesday 12th October 2016

South West Water is inviting farmers from the upper Exe catchment to find out about water treatment processes with an exclusive free tour of Pynes Water Treatment Works, near Cowley Bridge, Exeter. Pynes was built in 1832 in response to an outbreak of cholera in Exeter, after which it was decided to move the city's water source from Exe Street near the city centre to the less polluted Pynes Leat. Drinking water standards have come a long way since the days of the deadly cholera outbreak which claimed 440 lives. Visitors to Pynes on **Wednesday 12th October 2016** will be greeted by South West Water's water quality experts before being led around the fully operational site. Places on the free tour are limited and must be pre-booked. The tour will start at 11am and last for approximately two hours. A full safety briefing will be given on arrival at Pynes, but please wear sensible footwear such as walking boots or steel toe capped boots. Light refreshments will be provided after the tour.

NPTC Level 2 Certificate of Competence in the Transport of Animals by Road (short journeys)

This is for people who transport animals as an economic activity on journeys over 65km in distance and up to 8 hours in duration. Assessments will take place at our office based at **Cutcombe Market on Friday 21st October at 11am**. Cost: 1 Species £ 73.00(no vat), 2 Species £ 93.00 (no vat). Animal Transportation Information Sheet

Thank you for expressing an interest in the following:

1. NPTC Level 2 Certificate of Competence in the Transport of Animals by Road (short journeys) – this is for people who transport animals as an economic activity on journeys over 65km in distance and up to 8 hours in duration.

This is assessed through GOLA on a laptop computer (a multiple choice test of 27 questions, you will need to get 21 correct to be competent). If you need help using a computer mouse please indicate this on the registration form.

Species

Each area is divided into sub-species
Cattle and sheep, Pigs,
Sheep, Cattle,
Horses, Goats,
Poultry, Game
birds.

You will need to do a separate GOLA assessment in each species
NPTC have checked with DEFRA and it seems that you will have to hold the relevant certificate for all species you transport.

Schedule:-
